Competition rules

2024 ICF Wildwater Canoeing Wold Cup 1&2 will be run in accordance to ICF Wildwater Racing Competition Rules.

Access pass and parking

Free access pass and car parking near the athlete's village will be guaranteed for up to two accredited vehicles.

Boat storages

It will be settled in team areas with enough space for each team.

First Aid

Small Tent with medical services will be located near the finish area. The NF will advise participants that emergency medical services will cover only emergency cases and that all participants are responsible to arrange, at their cost, their own medical insurance policy.

Medical Insurance

HOC kindly asks all participants of the Championships to ensure medical insurance policy in their countries. All costs above the regular first aid, ambulance and physiotherapeutic services are to be covered by this medical insurance policy. HOC will not cover any expenses in connection with hospital or dental treatment.

Water Safety

Rescuing in competition area during the competition days will be organized.

Doping Control

Doping control will be performed in accordance to the ICF Anti-doping requirements and WADA standards.

Refreshments

A small tent with drinking water and refreshments will be available at the course.

Sanitary Areas

It will be settled in the middle of the parking area, at starting line and after the finish line.

Transportation

HOC will provide transportation services for teams between main airports, train stations and the accommodation for their own cost.

Security

Security for accredited people. Security personnel at the Venue will be present on-site 24 hours per day from 14th June – 16th June 2024.

General information about Veles

Veles is a city in the central part of North Macedonia on the Vardar river. The city of Veles is the seat of Veles Municipality.

Veles is the sixth largest Macedonian city with a total population of 43,716 (census 2002). The largest cities in the proximity of Veles are: Skopje – the capital and the largest city of North Macedonia – 54 km in the northwest direction, Štip 43 km to the east, Sveti Nikole 34 km to the northeast, Prilep 79 km in the southwest direction, and Kavadarci and Negotino 43 km and 40 km respectively to the southeast.

Veles is on the crossroad of important international road and rail lines. For all these reasons, Veles is considered to have a good geolocation within North Macedonia.
